1) Explanation to Point No. I (viii) "CIN, Name and Address of the Registrar and Transfer Agent"

During the financial year 2024-25, the Registrar and Share Transfer Agent ("RTA") of the Company changed its name from 'Link Intime India Private Limited' to 'MUFG Intime India Private Limited' effective from 31st December 2024.

2) Explanation to Point No. IV (i)(d) "Break-up of paid-up share capital"

The Company is required to provide details of Break-up of paid-up share capital at point no. IV (i)(d). Further, details like Increase or Decrease in number of shares (in Physical as well as Demat), Total nominal amount, Total paid-up amount and Total premium are also required to be provided under the said point.

During the F.Y. 2024-25, 2,97,695 Equity Shares were dematerialized by the shareholders who were holding them in physical mode. Therefore, we have mentioned the that no. of equity shares under the head Increase during the year "Others, specify" in the column of "Demat of shares held in physical form" and under the head Decrease during the year "Others, specify" in the column of "Physical" by specifying "Demat of shares held in physical form" respectively. The same is done in order to tally / reconcile no. of equity shares of the Company in Physical and Demat with the records of the Depositories and Stock Exchanges.

3) Explanation to Point no. VI. "Shareholding Pattern – No. of Shareholders and Gender wise bifurcation in – Breakup of Total Number of Shareholders (Promoters+Others)

In this category, the gender-wise bifurcation of the shareholding pattern has been compiled by the RTA based on the data extracted CDSL system. We have totally relied upon the data as provided by the RTA in this regard.

In previous year we had reported the total number of members by clubbing the PAN of the shareholders to match the number with the shareholding pattern filed by the Company with the Stock Exchanges. However, this year we have mentioned number of members as per the shareholders list received from the RTA and attached to the Form.

5) Explanation to Point no. VI.(C) "Details of Foreign Institutional Investors (FIIs) holding shares of the company"

- The RTA has provided the data pertaining to the country of incorporation of the FIIs based on the details registered in the demat account. It seems that in many of cases address of custodians of the FIIs who are located in India has been registered in the demat account. Hence the country of incorporation is mentioned as India for such cases as provided by the RTA.
- Details namely "Date of Incorporation" of FIIs could not been provided by / extracted from CDSL and NSDL, hence we have mentioned dummy date as 01/01/2000 for the entries of the FIIs made in the form.
- 3. In various cases the exact % of shareholding of FIIs is below the two digit decimal. The form is not allowing to mention % upto two digit decimal. Therefore, to validate the form we have mentioned % of shareholding as 0.01 % for such cases. The shareholding of FIIs have been provided separately as annexure A with actual no. of shares and %of shareholding for your perusal.
