The Company had filed the Special Civil Application No. 2683 in the year 2004 ("SCA") against the State of Gujarat, Collector of Electricity Duty, Chief Auditor, Industries Commission aggrieved by the notice issued by the Chief Auditor dated 12.1.2004 inter alia calling upon the Company to pay the amount of electricity duty.

The Hon'ble High Court of Gujarat has dismissed the said SCA filed by the Company.

The Company has already given the following disclosure in its last annual report:
