Mr. Sameer Subhash Khera (DIN: 00009317) retired as an Independent Director of the Company effective from February 25, 2025 on account of completion of his 2nd term. Mr. Mayank Natubhai Amin (DIN: 03455164) ceased to be director due to his sad demise on January 16, 2025 and Mr. Abhijit Achyut Joshi resigned as director, effective from February 08, 2025 due to his personal reasons.

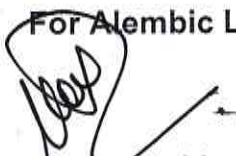

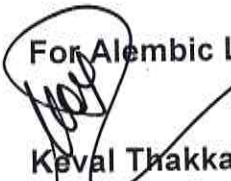
